剔除風險警示股 延新股納入時限

【香港商報訊】為提升指數編制的科學性,增強指數的表徵功能,上海證券 交易所和中證指數有限公司昨日宣布,將於2020年7月22日修訂上證綜合指數 的編制方案。本次修訂內容包括剔除風險警示股票、延長新股計人指數時間, 並納人科創板上市證券。受訪專家認為,此次上證綜指編制方案修訂有利於上 證綜指更加客觀真實地反映滬市上市公司的整體表現

充分借鑒國際經驗

上交所表示,完善指數編制方案是國際主流指數的 通行做法,此次上證綜指編制方案修訂充分借鑒了國 際指數編制修訂經驗

中國資本市場建立了風險警示制度,被實施風險警 示的股票風險較高。截至5月底,上證綜指樣本中包 含85隻風險警示股票。上交所的公告指出,剔除該類 股票對指數本身影響較小,但有利於發揮資本市場優

基於中國證券市場新股上市初期存在波動較大的現

間。上交所表示,將新股計入上證綜指的時間延遲至 上市1年後。考慮到大市值新股價格穩定所需時間總 體短於小市值新股,爲保持上證綜指的良好代表性, 對上市以來日均總市值排名滬市前10位的大市值新股 實行上市滿3個月後計入。

「由於主板新股在上市後存在嚴格的漲跌幅限制, 上市後大多有一個『補漲』過程,最高紀錄是30個漲 停板。」董登新說,因此,新股計入指數時間需要延 長。而考慮到科創板新股在上市前5個交易日沒有漲 跌幅限制,交易更充分,供求更真實,股價更均衡, 新股納入上證綜指樣本股的時間可適當縮短。

上交所還公布了上證科創板50成份指數,簡稱「科創 50 | ,指數代碼爲000688。以2019年12月31日爲基
